## **ORDINANCE NO. 834**

One and Freed Assessmentalisms

TO ESTABLISH OPERATING AND CAPITAL BUDGETS FOR THE OPERATION OF THE COUNTY GOVERNMENT OF FAIRFIELD COUNTY FOR THE FISCAL YEAR COMMENCING JULY 1, 2024; TO PROVIDE FOR THE LEVY OF TAXES FOR FAIRFIELD COUNTY FOR THE FISCAL YEAR COMMENCING JULY 1, 2024; TO ESTABLISH FEES AND SERVICE CHARGES FOR FAIRFIELD COUNTY FOR THE FISCAL YEAR COMMENCING JULY 1, 2024; TO PROVIDE FOR THE EXPENDITURE OF TAX REVENUES AND OTHER COUNTY FUNDS; TO PROVIDE FOR OTHER COUNTY PURPOSE; TO PROVIDE FOR CERTAIN FISCAL AND OTHER MATTERS RELATING TO COUNTY GOVERNMENT, AND OTHER MATTER RLATED THERETO.

**Section 1:** Be it ordained and enacted by the County Council of Fairfield County, South Carolina: extending through June 30, 2025, the following sums are hereby appropriated from the general fund of Fairfield County to meet the ordinary expenses of the County as hereafter indicated.
